# TREASURER'S REPORT AND ACCOUNTS 2019-2022

This report covers the last three financial years 2019-20, 2020-21 and 2021-22 ending on 31 October 2022. The report and accounts for the year 2018-19 were approved at the 2019 AGM.

In October 2019 the Forum had £4,218.51 in the bank. This comprised £3,739.41 reserves in the 'Accumulated Fund', money which is available to pay for any permitted activities, and £479.10 in the Godstow Abbey Project fund, which is ring-fenced money remaining from the installation of the public information display on the towpath near the Abbey ruins.

### 2019-2020

The accounts for 2019-20 (below) show that about a third of the reserves were spent in that year on finalising and publishing the Neighbourhood Plan. In addition, there were the usual costs of the website and room hire for committee meetings, and the Forum joined the Oxfordshire Neighbourhood Plans Alliance (ONPA) at a reduced membership rate applicable to areas whose plans had not yet been approved.
